The Rooiberg Working on Fire team have been fully booked for landowner assistance (production) from 15 January up to 15 June 2018.

Rest assured that we are doing our utmost to rectify discrepancies created in the past and make an urgent plea to landowners making use of the teams to contact this office during production if you encounter problems. This will enable us to rectify complaints immediately. The Rooiberg team is fairly new when it comes to production and attempting to straighten out all difficulties encountered.

Also note that all crew members from Rooiberg Working on Fire base signed a declaration of non-disclosure. Crew members attached to the Vingerkraal base will also sign the declaration of non-disclosure.

Landowners are requested to plan production activities in advance according to the total number of crew, equipment available at the different bases e.g. total number of chain saws, brush cutters, slashers, rake hoes, nap sacks etc. and total members trained to operate the different equipment. If need be, to divide the team into 2 or 3 groups, each group must be accompanied by a Crew Leader and will not be allowed for the crew to operate without supervision.

Working on Fire Rules and Regulations instruction manual for crews working in close proximately to dangerous animals:

Working on Fire crews are required at times to assist with fire suppression or work in areas where they could come into contact with dangerous game including lion, elephant, rhino, leopard and buffalo.

The landowner/manager/representative will be required to:

- Supply physical human protection (Armed ranger)
- Fire line crews will only be allowed to operate within an area guarded by two game rangers
- No crew member will be allowed to operate individually
